The competition takes place in accordance with the Regulation of “Baltic Minicup 2019” and LaMSF Trial rules and supplementary regulations of this competition.

5. Participants and Classes

Mini C	Children up to 12 with electro or internal combustion motorcycles (up to 80cc)	5 stages, 2 rounds
Mini B	Children up to 12 with electro or internal combustion motorcycles (up to 80cc)	5 stages, 3 rounds
Mini A	Children up to 12 with electro or internal combustion motorcycles (up to 80cc)	5 stages, 3 rounds
Dip Dap	Children with balance bicycle without age limitation	5 stages, 2 rounds

* Classification in accordance with skill level: “Mini A” (most difficult), “Mini B” (medium), “Mini C” (easiest). Maximum age limit 12 years (i.e. born in 2007, reaching 12 in 2019).

6. Time schedule

7. Awarding

All riders will be reward with medals, diplomas and gifts from sponsors. All riders must obligatory attend award ceremony.

8. Entry fee and licences

8.1 Entry fee is 10 eur. Entry fee must be paid in race day in Euros.

8.2. It is necessary to have valid their FMN national license. One event license costs 2 eur. Riders must have insurance policy valid for motorsport.

10. Safety and Responsibility

- Each participant must have an assistant who is responsible for the young rider during the competition and necessarily assists at the sections, otherwise the clerk of course can bar from participation in the stage. The assistant shall be registered for each stage of the competition in the morning at the secretariat when the rider is registered.
- Approving the child's participation in the competition, the parents or their representatives shall abandon any claiming against the organizer or other persons involved in organization of events after occurrence of a possible accident or material damage and shall not contest the compensation for damages in court;
- The participant and the visitor to the competition shall be informed that filming and photographing may be carried out during the event on the organizer part, as well as publication of the results. When registering at the event as a participant, parents or representative of an underage participant by their signature on the form shall agree that the participant may be photographed and filmed, that its image may be used in films, photos and audiovisual recordings, that its results in the competition may be published at the venue of the competition and in communication tools of the organizer or other persons authorized to do so. All rights to such materials and use thereof shall belong to the organizer or to respectively authorized third person; the organizer or respectively authorized third person may use such materials at its own discretion all over the world, in any mass media, for advertising or other purposes, including commercial, without whatever compensation or remuneration for the abovementioned to the visitor;
- The organizer shall not be held responsible before the participants if the participants are not aware of or do not observe the present Regulation.
